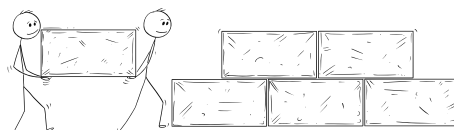

Welcoming Our New Deputy Director - Carrie Broniec!

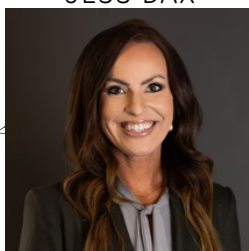

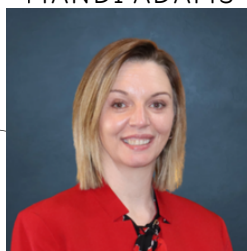

As we close out the year, I want to wish each of you a safe and wonderful holiday season. Merry Christmas to everyone, and may you have a blessed and joyful New Year.

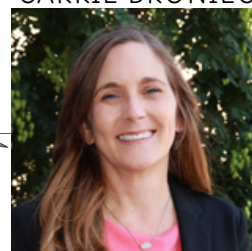

New Legacy Scholarship Award in Dedication of Michael Shortridge

MCSEA past president, Dan Pingleton, chose to honor the legacy of Michael Leigh Shortridge, a lifelong supporter of MCSEA and the child support program, by sponsoring a new annual scholarship in his name. Michael "Mike" Shortridge was an attorney who served for a number of years as Child Support's General Counsel and spent his time fighting for the wellbeing of the program and the citizens of Missouri who counted on our Division to deliver those services. Mike was a brilliant legal mind, a fierce litigator, and an even better friend. A mentor to many, Mike encouraged, supported, and promoted many employees by investing in them both professionally and personally; there are several of us who have Mike to thank for our perspective if not our careers. Mike's wife, Elaine Shortridge, was on hand for the celebration; she is also a retiree from the Child Support Program having served in many roles over the years, but most notably as the Office Manager of the CS Interstate Unit. The couple's love story began at an MCSEA conference, you see, you just never know what is going to happen at an MCSEA Conference, it could change the course of your whole life!

The Award description reads:

The Michael Shortridge Legacy Award honors the memory of Michael Shortridge, a man known for his integrity, sharp wit, and unwavering commitment to doing the right thing through the law. Mike was never pretentious—he approached his work and his colleagues with humility, humor, and a deep sense of purpose. His legacy continues to inspire those who share his dedication to justice, fairness, and service. The recipient of the Michael Shortridge Legacy Scholarship will receive a full ride to the following year's Conference which includes registration and hotel accommodations and is given to award and honor someone doing work in the legal field and who embodies the qualities for which Mr. Shortridge was known. The first winner of the new Michael Shortridge Legacy Award was Karen Haley of the Union PA Project.

Said of Ms. Haley in her nomination:

This year's recipient embodies the very qualities that made Mike so respected and admired. In her work ethic, her approach to child support work, and her personality, she reminds us of Mike's enduring influence. She demonstrates the same steadfast commitment to doing what is right, guided by both compassion and the law. Her professionalism, integrity, and quick wit reflect the spirit that Mike brought to every challenge and every conversation. She may not be an attorney, but she was chosen as the winner of the first Michael Shortridge Legacy Award For her dedication to her work and her colleagues which exemplifies the values that the was created to celebrate. Through her actions and attitude, she carries forward Mike's legacy—proving that integrity, humility, and a good sense of humor remain the foundation of meaningful public service.

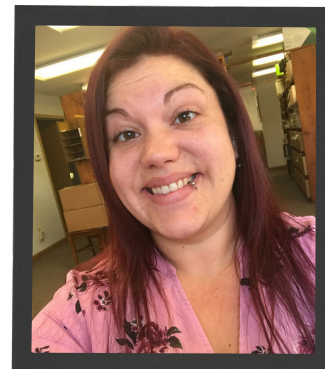
A Message from the President

What is MCSEA?

The Missouri Child Support Education Association (MCSEA) is a non-profit 501(c)(3) organization that promotes the advancement and education of its members and others involved in the administration of child support programs and the delivery of their services.

How Can I Become a Member?

To be a member you must be:

- A current or retired employee of the Family Support Division Child Support;
- A current or retired employee of a contract partner of Child Support; or
- A current or retired employee of a circuit clerk office doing the work of child support.

Over the years, Nathan's Catch has given away more than 600 fishing poles at the Get MO Wild Event each fall. Nathan's Catch hopes to give away more fishing poles and tackle boxes to children this year and needs your help.

In addition to this year's charity raffle to benefit MCHS, MCSEA wants to highlight Nathan's Catch, a program sponsored by MCHE. 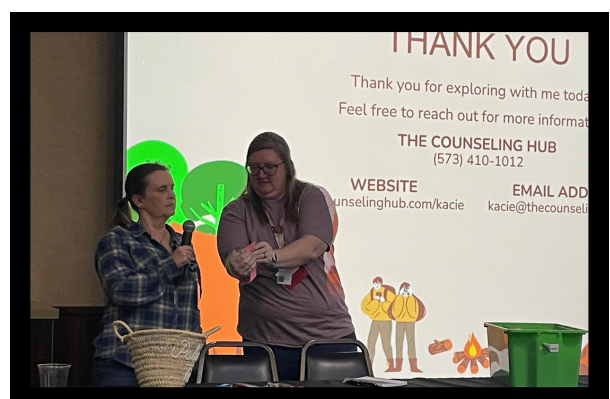
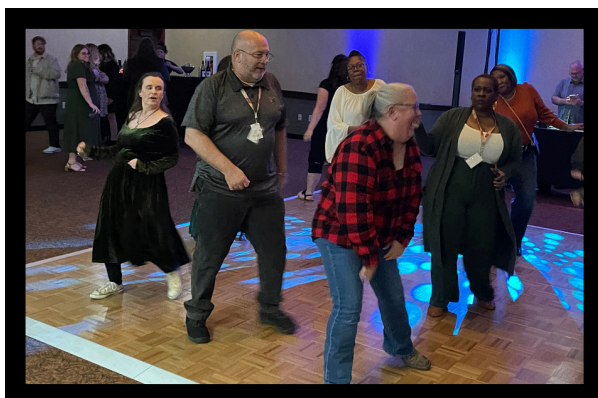
