### Kids in the Middle Empowering Children & Families

One of the most wonderful activities we have at MCSEA's Annual Training Conference is the raffle to benefit a Missouri children's charity. Everyone working in Child Support works hard to help families receive the support they need from both parents so they are able to learn and grow into the adults they are meant to become. We assist parents, both the parent paying and the parent receiving support, address the barriers to meeting their parental obligations, so they are better able to be parents, together and separately. Kids in the Middle serves these same families.

KITM is a nationally accredited agency that exists to assists children, parents, and families' transition to a new way of life before, during, and after



separation and divorce. Their mission is to help families move forward, create and achieve new family goals, and enable them to transition to a healthy, balanced future. Kids in the Middle offers educational and supportive services such as individual and family counseling as well as parenting classes. Counseling will address the mental, cognitive, and behavioral health of children whose families are in transition to a new family life. These services teach positive coping skills, to empower and support the family as they move through this life changing process. Because KITM utilizes a unique policy of not releasing case records with specific information, this allows therapists to remain neutral; to just "be there" to ensure children and their families have a safe, confidential, and nurturing environment to work through their feelings.
